Any federal civilian or DoD agency may use this contract to fulfill a broad range of mission-critical IT requirements as diverse as Data Migration, Cloud Computing, Program Management, and Health IT. The CIO-SP3 SB contract is managed by the National Institutes of Health (NIH) Information Technology Acquisition and Assessment Center (NITAAC). The NITAAC Customer Support Team offers live representatives (M-F, 8 am-6 pm), complimentary training, and a library of tools and templates to help facilitate acquisitions. The electronic Government Ordering System (e-GOS) offers fair opportunity and streamlined market research, includes applicable FAR clauses, removes the requirement for a formal evaluation plan/scoring, and allows federal staff the ability to set timelines for awards, meet small business goals by determining set-aside preferences and agency-specific terms and conditions.
